Prize Draw Terms & Conditions

1. Eligibility

1.1. This prize draw is open to anyone in the UK who follows Youth Sport Trust ("YST") on social media.

2. Prize Draw Entry Period

- 2.1. There are three prize draws, each with three winners.
- 2.2. The first prize draw opens at 00:01 on Monday 21 November 2022 and closes at 23:59 on Thursday 1 December 2022. Entries received after Thursday 1 December 2022 will not be entered into the prize draw.
- 2.3. The second prize draw opens at 00:01 on Saturday 3 December 2022 and closes at 23:59 on Sunday 11 December 2022. Entries received after Sunday 11 December 2022 will not be entered into the prize draw.
- 2.4. The third prize draw opens at 00:01 on Tuesday 13 December 2022 and closes at 23:59 on Sunday 18 December 2022. Entries received after Sunday 18 December 2022 will not be entered into the prize draw.

3. Entry Requirements

3.1. To enter this prize draw, schools must follow Youth Sport Trust on Facebook, Instagram, Twitter or TikTok and share a video or photograph of themselves demonstrating one of the skills in the YST #HalfTimeChallenge videos or downloadable worksheets. Entrants must use the #HalfTimeChallenge on their post to be eligible.

4. Winner selection, notification and prizes

- 4.1. All eligible entries will be downloaded from Instagram, Twitter, Facebook and TikTok and entered into a spreadsheet. Three winners will then be picked at random from all eligible entries posted on school social media accounts during the prize draw entry period, using Google Random Number Generator.
- 4.2. There will be three winners per prize draw. The winning entries will be notified by social media direct message on the following dates:
 - a) First prize draw: 2 December 2022 Prize: A FIFA World Cup training football
 - b) Second prize draw: 12 December 2022 Prize: A FIFA World Cup training football
 - c) Third prize draw: 19 December 2022 Prize: A FIFA World Cup training football

N.B. Please note that neither the YST nor this prize draw have any official affiliation with the FIFA World Cup.

4.3. If any winning entry does not respond within 48 hours or is not able or available to accept the prize for any reason which is beyond the Promoter's reasonable control, then the Promoter reserves the right to award the prize to another entrant.

5. Data Protection

- 5.1. Any personal data will be processed by Youth Sport Trust in accordance with its Privacy Notice.
- 5.2. By submitting images to the prize draw, each entrant confirms and warrants that:
 - a) in accordance with UK data protection legislation, they have the prior permission of those pictured in the image (or, where the image shows any persons under 18, the consent of their parent/guardian) to submit the image; and
 - b) if they are the winner, the Promoter has permission to make any included names available and may use these (and the name of the entrant's school, if appropriate) as detailed in clause 7, without additional remuneration.

6. Copyright and permissions

e) they have received any necessary permissions from the owner(s) of buildings, trademarks and copyrighted materials included in submitted images for the usage rights detailed in clause 7 and will indemnify YST against any claims made by any third parties in respect of such infringement.

7. Usage Rights

- 7.1 By entering the prize draw, you grant YST a non-exclusive, irrevocable licence to reproduce, enlarge, publish or exhibit, on any media throughout the world, any image **connected with the prize draw** (including any related credit or caption information) for any purpose, without additional remuneration, with the right to sub-license where necessary.
