



Youth Sport Trust Conference 2022: *Inspiring Changemakers*

Terms & Conditions

Orders and acceptance

- 1.1 The delegate is deemed to accept these terms and conditions (the “**Terms**”) upon registering for the YST 2022 Conference (the “**Event**”) and is responsible for ensuring the accuracy of all details submitted.
- 1.2 These Terms govern the booking for the Event and attendance at the Event. The Event website incorporates these Terms, and they constitute a legally binding contract at the point of booking.
- 1.3 The closing date for bookings is 17:00 on Friday 18th February 2022, or earlier should capacity be reached.
- 1.4 Confirmation of the booking will be sent via an automated email at the time of registration.
- 1.5 The Youth Sport Trust will not reserve places. Places are offered on a first come, first served basis; the only delegates who have a guaranteed place at the Event are those who have received the email acknowledgement in 1.4.

Fees

- 2.1 The prices for the YST 2022 Conference are per delegate (“**delegate fee**”) and include all fees, materials and refreshments.
- 2.2 We will endeavour to accommodate all dietary requirements providing that the delegate provides this information within 14 days of the Event, however we are unable to guarantee this.
- 2.3 All prices exclude VAT at 20%, unless otherwise stated.
- 2.4 Accommodation is not included within the delegate fee. All accommodation must be booked independently of the Youth Sport Trust.

Discount codes

- 3.1 Only one discount code may be redeemed per booking
- 3.2 All discount codes are non-transferrable and must only be used by the qualifying user account.
- 3.3. The discount code cannot be used after the order has been placed.
- 3.4 We reserve the right to amend or withdraw discounts and promotions at any time and for any reason, without prior notice.
- 3.5 Even if a code is accepted at check out, all orders are reviewed by the Youth Sport Trust prior to completion. If orders are deemed in violation of any of these Terms, they will be adjusted accordingly.

- 4.1 Payment in full must be received and cleared by the Youth Sport Trust as per the invoice payment terms. We accept payment by selected debit/credit cards, or bank transfer.

Cancellations

- 5.1 The Youth Sport Trust reserves the right to cancel or postpone the Event without notice. In the case of the Event being postponed, whether this is at the Youth Sport Trust's discretion or due to imposed national restrictions, delegate registrations will automatically be transferred to a revised date. For any delegates unable to attend this revised date, a refund will be issued. This request for a refund must be communicated in writing to events@youthsporttrust.org. Any refund will be limited to the amount already paid by the delegate to secure their place at the Event.
- 5.2 In the event of cancellation by a delegate, cancellation fees will be due as follows:
- Cancellations received prior to 17:00 on Friday 4th February 2022 will incur a £20.00 cancellation fee.
 - 100% of the delegate fee will be charged for cancellations received after 17:00 on Friday 4th February 2022.
- Substitutions will be permitted.
- 5.3 All cancellations or substitutions must be received in writing to: events@youthsporttrust.org
- 5.4 If a delegate is unable to attend the Event owing to a requirement to self-isolate, due to Covid-19, a refund will be issued (delegates may be required to show proof of a positive Covid-19 test, or other requirement to self-isolate). Any refund will be limited to the amount paid by the delegate to secure their place at the Event.
- 5.5 If applicable, refunds will be paid as soon as possible, or within 30 days.

Force majeure

- 6.1 The Youth Sport Trust will not be liable for any failure or delay in the delivery of the Event which is caused by circumstances beyond its reasonable control.
- 6.2 Where such circumstances occur, the Youth Sport Trust's obligations will be suspended for so long as such circumstances continue, or the Event may be cancelled, in which case the provisions of clause 5.1 will apply.

Venue and content of event

- 7.1 The Youth Sport Trust reserves the right to change the venue of the Event from the venue specified, when necessary. In the case of changes to the venue, the Youth Sport Trust will inform delegates as soon as possible and provide information about the revised venue. If a change of venue occurs, the Youth Sport Trust will not be liable for any additional costs incurred by delegates.
