

Girls' Football Youth Sport Award

Terms and Conditions



1. Eligibility

- 1.1. This prize draw is open to schools who received training in the Girls' Football Youth Sport Award ('the Award') in the 2018/19 academic year.

2. Promotional Period

- 2.1. The prize draw period opens on Monday 24 February 2020 and closes on Thursday 5 March 2020. Surveys completed after this period will not trigger an automatic entry into the prize draw.

3. Entry Requirements

- 3.1. To enter this prize draw, schools must complete the Award survey available at <https://youthsportdirect.typeform.com/to/HDI5HA> by the end of the prize draw period.
- 3.2. On submission of a fully completed Award survey, schools will be automatically entered into a prize draw to win one of ten football equipment packs.

4. Winner selection, notification and prizes

- 4.1. The winning prize draw entries will be randomly selected by the Youth Sport Trust from all eligible entries received during the prize draw period.
- 4.2. The prize draw winners will be notified by phone or email by 10 March 2020.
- 4.3. If the winners have not responded by 24 March 2020 or are not able to accept the prize for any reason which is beyond the Promoter's reasonable control, then the Promoter reserves the right to award the prize(s) to another entrant.

5. Data Protection

- 5.1. Any data collected specifically for this prize draw promotion will be used solely for administering the promotion and contacting the winners – this data will be deleted one month after the close of the promotion.
- 5.2. By entering this promotion, you agree that, if your school is one of the winners, the Promoter may make your county and school name available and may use your county and school name for publicity purposes without additional remuneration.
